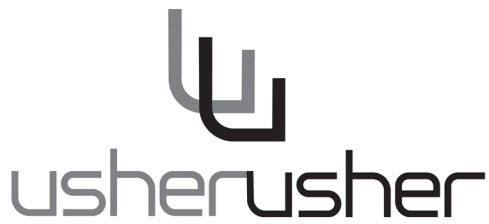

Payment can be made by credit card, cheque, direct deposit or cash. The booking fee is payable to secure the booking. The final payment of the package is payable **4 weeks prior to the wedding date**. Invoices will be emailed out prior to payment. Invoices will be made out to the couple unless alternatively directed. Receipt for payment will be emailed at the end of the relevant month.



CONTRACT

This agreement is made between UsherUsher and the Clients as detailed.

have read, understood, and agree to the following:

1. To reserve the wedding date, UsherUsher requires a booking fee of \$900.00. On the signing of this agreement, both parties agree that UsherUsher will not make another reservation for wedding photography on the wedding date. In the event of cancellation or change of date, any booking fee paid by, or on behalf of the Clients is non-refundable.
2. The final payment of the Package must be received by UsherUsher 4 weeks before the wedding date or unless payment plan has been devised and agreed upon by both parties. The Package is the agreed upon services and products outlined in the Booking Form. Any changes to the Package will be done so in writing by both parties.
3. UsherUsher will be advised in writing by the clients at least twelve weeks prior to postponement or cancellation.
4. UsherUsher and Clients agree that unless otherwise stated in this document, UsherUsher owns any and all copy and reproduction rights. Clients agree not to reproduce or copy any proof or photograph of the wedding, taken by UsherUsher, without Usher Usher's written permission, or without purchase of reproduction and copyrights. Any unauthorized reproduction of proofs or photographs, or failure to return the proofs to UsherUsher, (if applicable) constitutes a breach of this agreement and will subject Clients to any and all applicable civil penalties.
5. UsherUsher will keep all digital negatives, in the format they were created for a period of 5 years after the wedding date.
6. Clients agree that UsherUsher may use any photograph, or part thereof, for publicity purposes that he chooses containing images from the wedding even after Clients have purchased reproduction and copyrights from UsherUsher. Such publicity may include publication on UsherUsher's Internet website, entrance to photographic competitions, and public display and exhibition. Clients agree to release all claims to profits that may arise from the use of the images.
7. In the unlikely event that UsherUsher is injured or becomes too ill to photograph your wedding, every effort will be made to secure a replacement photographer. If the situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received for the photography package. Utmost care will be taken with respect to exposure, transportation, and processing the photographs. However, in the unlikely event that photographs have been lost, stolen, or destroyed for reasons within or beyond UsherUsher's control, liability is limited to the return of all payments received for the photography package. The limit of liability for partial loss of originals shall be a prorated amount of exposures lost based on the percentage of total number of originals.



- 8. The Clients agree to give in advance UsherUsher all relevant details for the day and to advise of any changes.
- 9. The Clients will advise all relevant persons of the time schedule agreed upon with Usher Usher and agree not to impede the photography times and/or sessions in any way.
- 10. Photographic services include one album planning meeting up to 4 hours in duration. All additional hours will be billed at \$100 per hour. Album plans are only available Monday to Friday (excluding public holidays) starting at 10am and commencing no later than 4pm.
- 11. Disc of high resolution images, if purchased, will be provided to Client(s) upon finalisation of their album order. Please allow up to twelve (12) weeks for album/book manufacture once approved by Clients.
- 12. Images are edited and colour processed at UsherUsher's sole discretion, and delivered prints or digital files may not include all images captured. Clients agree that UsherUsher reserves the creative right to edit, colour process and release only those deemed as "professional quality" and within the photographers artistic standards.
- 13. UsherUsher and Clients agree that no other hired stills photographer will be present at the wedding, and that unless otherwise agreed to and stated in this Agreement, no other cameras are to be operated at the Location photoshoot. A wedding day is a spontaneous, unrehearsed, fast-moving event. UsherUsher will make every attempt to produce fine photographs of all important aspects of the wedding day, however no specific photographs or images can be guaranteed due to the nature of this event.
- 14. Agreed fee is based on UsherUsher's current standard price list at the time of signing this Agreement. Current standard pricing in this contract is valid for six (6) months after the wedding date. All orders, including albums, placed after that date are subject to the standard price list in effect on the date of the order.
- 15. This agreement is understood and agreed to by all listed parties.
